KRS 132.487 REQUIRES ALL APPLICABLE TAXING DISTRICTS THAT PROPOSE TO LEVY A TAX ON MOTOR VEHICLES VALUED AS OF JANUARY 1, TO SUBMIT TO THE DEPARTMENT ON OR BEFORE O<u>CTOBER 1</u> OF THE YEAR PRECEDING THE ASSESSMENT DATE, THE TAX RATE TO BE LEVIED AGAINST VALUATIONS AS OF THE ASSESSMENT DATE. ANY DISTRICT THAT FAILS TO TIMELY SUBMIT THE TAX RATE SHALL RECEIVE THE RATE IN EFFECT FOR THE PRIOR YEAR.

A number of motor vehicle tax rates have been submitted to the Department of Revenue in the past which may not have been calculated correctly. Some jurisdictions used compensating rates or calculations based upon House Bill 19.

Please note that MOTOR VEHICLE TAX RATES ARE NOT dependent upon compensating rates or the 4% limitations set forth in House Bill 44 or House Bill 19. Instead, all local taxing districts that propose to tax motor vehicles can levy a rate on motor vehicles that does "not exceed the rate that could have been levied on motor vehicles by the district on January 1, 1983 assessments of motor vehicles." Thus, a local district may levy a rate up to the maximum available 1983 tax rate for motor vehicles.

## UNIVERSITY OF KENTUCKY COOPERATIVE EXTENSION SERVICE INSTRUCTIONS FOR COMPLETING MOTOR VEHICLE TAX RATE RETURN LETTER

The Motor Vehicle Tax Rate Return Letter provides the Kentucky Department of Revenue the tax rates levied by the local taxing jurisdictions on Motor Vehicles.

### BOX 1 – Prior Year Tax Rate (Cents Per \$100 of Assessed Value)

The information contained here will come pre-filled from the Department of Revenue and will be specific to each county. The box will contain the tax rate that was elected in the previous year. The rate will be reflected in cents per \$100 of assessed value). This box is for reference purposes only.

### **BOX 2 – Name of Taxing Jurisdiction**

The information contained here will come pre-filled from the Department of Revenue and will be specific to each county. The box will contain the name of your specific extension service taxing district. **This box is for reference purposes only.** 

### BOX 3 – Current Tax Year Levied Tax Rate

This portion of the form will be completed and filled in with the rate (reflected in cents per \$100 of assessed value) once approved by the Extension District Board.

NOTE: <u>MOTOR VEHICLE TAX RATES ARE NOT</u> dependent on compensating or the 4% limitations. Instead all local taxing districts that propose to tax motor vehicles can levy a rate that does "not exceed the rate that could have been levied on motor vehicles by the district on January 1, 1983 assessments of motor vehicles". Thus, a local district may levy a rate up to the maximum available 1983 tax rate for motor vehicles.

# **BOX 4 – Signature of Tax District Representative**
