FEDERAL CAPACITY FUNDS

Uniform Guidance Procurement Standards

As previously communicated in the February UFS Advisor, effective 7/1/18, the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (Uniform Guidance) Procurement Standards (2 CFR 200.317 -.326) will go into effect on all Federal and Federal flow-thru awards July 1, 2018. This includes federal capacity funds. The new requirements could have significant impacts for units that frequently make purchases from non-contracted vendors. UFS has been/will be offering town hall meetings to provide additional information as the university prepares for this transition. Standards will be conveyed for competitive pricing requirements, conflicts of interest,

travel, documentation required, etc. All units are encouraged to attend one of the Town Hall sessions for staff, and/or the Hand-in-Hand presentation on May 24th. Registration for Hand-in-Hand sessions can be completed in ESS using the Training link.

Staff Shared Leave Pool Program Donations



As you know, due to ACA, temporary employees with an FTE of 75% or higher are offered the UK health insurance credit. However, there is an exception for seasonal employment (an assignment less than three months). In order for the UK Benefits Office to be aware that the employee is seasonal, please remember to <u>select the seasonal flag on screen 7</u> when processing the personnel action.



Staff Professional Development Fund – Update

The college established the Staff Professional Development Fund in FY18 to support professional development for CAFE staff.
